3. I understand and agree that acceptance by the school shall consist of this contract being signed by its duly authorized representative(s), and enrollment of your student(s).
4. I understand and agree:
  - a. that a student is enrolled for the full year;
  - b. that no tuition refund will be made by the Religious School for the dismissal, suspension, withdrawal or absence of a student; and
  - c. that I am responsible for the full tuition for my student(s).
5. Tuition Payment: I understand and agree that I will select one of the following payment options and adhere to all conditions thereof.
  - Payment in full for my student(s) by 7/31/19 and receive a discount of \$75.00 off the cost of tuition for each student. I have enclosed a check made out to Congregation Shaarey Zedek, or my signed Payment Authorization form is attached, and the amount of payment is \$\_\_\_\_\_. For Grades 3-7 Only.**

I understand that FAST will provide their determination to CSZ who will contact me to discuss options thereafter.**
6. Obligations of Parent(s)/Guardian(s):
  - a. I understand and agree that the right of the student to continue attendance is contingent upon committing to one of the payment options outlined under paragraph 5. I further understand and agree that CSZ has the right to suspend all bar/bat mitzvah preparation activities, as well as the bar/bat mitzvah itself, until all financial obligations are paid in full.

b. I understand and agree that in order to register for the new school year, tuition for previous years must be paid in full and I will contact CSZ by August 15, 2019, and make arrangements to pay any outstanding tuition and/or dues balances.

c. I understand and agree that the student and his/her parent(s), and/or guardian(s) are required to read and fully adhere to all provisions of the Student Handbook. I understand that a violation of such provisions may result in student discipline, suspension, or dismissal by the Religious School.

d. I understand and agree that in the event that my student is permanently suspended or dismissed or leaves for any other reason, outstanding tuition and other fees owed must be paid within 30 days of the student's last day at the Religious School.
